

#### **Questions & Answers**

Q: If the resident does not have a cell phone or computer do they still get voice alerts on their normal telephone?

A: Yes, they will always default to a voice message on their telephone.

Q: If I do not use my entire alerts in the package in a year, can I use them the following year?

A: Alerts do not expire you have them until your use them up.

Q: Can the other city departments purchase their own alert package?

A: Yes, they can purchase larger or small alert packages and alerts can be shared.

Q: Are there any limits to sending the alerts, either length or text?

A: No, most alerts are less than 60 seconds, however email can be longer.

Q: Can we send a newsletter attached to the email alert?

A: Yes, emails are allowed to have attachments.
